1. Manufacturing companies of which the operations have been suspended or restricted:

- (ii) If there are disruptions or delays in the supply chain of raw materials thereof or subcontractors, or in the distribution network;
- (iii) If a person infected with COVID-19 is confirmed in a manufacturing company/plant and it is necessary to suspend operations in such manufacturing company/plant; or

(iv) If there is any negative impact or effect on the business activities of TAIYO YUDEN Group companies due to issues arising from COVID-19
